**RESOLUTION NO. LAFC 1271  
RESOLUTION OF THE SACRAMENTO LOCAL AGENCY  
FORMATION COMMISSION ACTING AS THE CONDUCTING AUTHORITY TO  
APPROVE AIRGAS NCN, INC., REORGANIZATION (05-02)  
[Annexation to City of Sacramento;  
Detachment from CSA #1, Southgate Recreation &  
Park District, Sacramento Metropolitan Fire District, County Water  
Zones 12, 13, 40, 41, Florin County Water District,  
And Sacramento Metropolitan Storm Drainage Maintenance District]**

WHEREAS, a petition proposing the annexation of 14.8 +/- acres to the City of Sacramento and detachment of said territory from County Service Area #1, Southgate Recreation and Park District, Sacramento Metropolitan Fire District, County Water Zones 12, 13, 40, 41 and Florin County Water District, (05-02), was heretofore filed by the City of Sacramento with the Executive Officer of this Commission, and the Executive Officer examined said petition and determined that said filing was sufficient; and

WHEREAS, the Commission considered the merits of this proposal and determined that the proposed Reorganization was consistent with the Commission's purposes and responsibility for discouraging urban sprawl, preserving open space and prime agricultural land, efficiently providing governmental services, and encouraging the logical and orderly development and coordination of local governmental agencies so as to advantageously provide for the present and future needs of the county and its communities; and

WHEREAS, the Commission approved the CEQA Mitigated Negative Declaration for this project and approved the *AIRGAS NCN, INC., REORGANIZATION* in Resolution No. LAFC 1268 adopted March 3, 2004; and

WHEREAS, the Commission acts at this time as the conducting authority and has taken further proceedings in this matter in compliance with the applicable law; and

WHEREAS, the Commission noticed and set the proposal for protest hearing; and

WHEREAS, following summarization of the Commission's resolution at the protest proceeding, the Commission opened the proceeding to hear and receive oral and written protest; and

WHEREAS, written or oral protests or objections were received and withdrawn;
