Adopted Budget

RECOMMENDATION

Approve the attached Appropriation Adjustment Request (AAR) amending the FY 2006-07 Adopted Budget. This AAR increases appropriations in the amount of \$135,000 and revenues in the amount of \$110,000 and transfers \$25,000 from Contingencies to Other Professional Services.

DISCUSSION

Expenditures are higher than budgeted for environmental services and legal services and salary and benefits. The legal and environmental expenditures are offset by higher revenues. The unbudgeted salary and benefits are not offset by higher revenues. This issue has been discussed in the proposed and final budget reports. The increased net cost should result in a lower savings carryover for FY 2007-08.

The attached AAR increases these accounts so that there should be sufficient appropriations authorized to make payments on invoices for FY 2006-07.
