The proponents will work with staff to establish a payment schedule, with deposits to be made prior to work proceeding, the proceedings will be subject to full cost recovery for the EIR, CFA, MSR, legal and any other costs incurred, other than Commission staff costs, with indemnification to be provided by the Incorporation Committee. Commissioner Yee offered a friendly amendment to clarify that all costs above \$200,000 will be funded by the incorporation proponents. Commissioner Miklos accepted the friendly amendment. The motion was seconded by Commissioner Jones and unanimously passed.

Item # 6: PROPOSED FY 2007-08 BUDGET

Final budget was approved, including \$100,000 special assessment for Arden-Arcade Incorporation.
