Dear Peter, Don, Nancy,

Following up on my e-mail messages to Don and Nancy yesterday, we have reviewed a few Form 460's filed by Commissioners. The Form 460 filed by Commissioner Jimmy Yee shows receipt of campaign contributions on January 11, 2007, of \$250 from Angelo Tsakopoulos and \$250 from Eleni Tsakopoulos-Kounalakis. This is on pages 8 and 9 of the Form 460.

As you know, both are officers and agents of AKT development, which is a participant in the LAFCo proceedings and has major financial interest in the Greenbriar property and proposed development, and thus a financial interest in LAFCo's proposed actions at the upcoming hearing on Greenbriar.

As Nancy correctly points out in her memo to Commissioners dated August 3, 2007, the FPPC prohibition against campaign contributions exceeding \$250 for the 12-month period preceding the LAFCo action applies to the action pending before LAFCo due to the fact that the City requested that all land use entitlement issues be included in the SOI EIR which will be considered for certification by LAFCo at its September 19 hearing. The EIR addresses not only the SOI expansion, but also the proposed project-specific land use entitlements by the City and will be relied upon by LAFCo when it considers annexation. On September 19, 2007, LAFCo will also consider approving mitigation measures and an MSR which will affect subsequent land use entitlements and annexation.


So it appears that Commissioner Yee will need to disqualify himself for the September 19 hearing on Greenbriar. It would be best if LAFCo staff discussed this with him, if he has not already communicated about this.

Commissioner Yee's Form 460 also shows campaign contributions of \$250 each on 1/11/07 by Chrisanthy Tsakopoulos Investments, Athena Tsakopoulos Investments, Katina Tsakopoulos Investments, and Alexandra Tsakopoulos Investments. I don't know if these contributors have a financial interest in the project or the land (which would encompass a financial interest in

Greenbriar or an LLC/LLP having a financial interest in the project or land). However, the Form 460 shows the address for each of these contributors as 7700 College Town Drive #101, which is also the address of AKT Development.

I will follow up with a phone call to Nancy. We still need to check Form 406's for a couple of other Commissioners. Thank you very much.

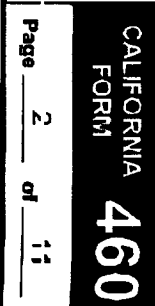
