The current proposed budget represents no change or increase cost to the Incorporation Proponents from the August 15, 2007 hearing date. Legal cost during the transition period will not be charged to the Proponents. Burr Consulting has terminated the agreement with LAFCo; LAFCo accepted the termination. Burr Consulting will provide all data they have completed, and provide assistance during the transition period. Consultants need to start work by August 1, 2008. Several options were discussed regarding payment and timelines. Commission requested a report in June that focuses on the possible funding/payment options.

 City of Sacramento Reorganization Annexations/Reorganization of Greenbriar Territory Report Back (LAFC 02-08)

During the next few weeks, staff will work with the Project proponents on final paperwork. Once that is complete, the Certificate of Completion will be filed. The effective date of the Annexation will be dependent on when the Certificate of Completion is filed. Then 30 days hence of that filing the paperwork will be sent to the State Board of Equalization and that will close LAFCo proceedings for the Annexation.

Note: The lawsuit, by Environmental Council of Sacramento (SACOG) and Friends of the Swainson's Hawk, was amended to include the annexation. Both LAFCo and the City of Sacramento are included in the suit.
